TFHNJ works to reduce tobacco use and the negative impact of secondhand smoke throughout all counties of New Jersey. TFHNJ creates synergistic opportunities to engage local coalitions and public health advocates to promote tobacco control initiatives in their prevention work!

The Great American Smokeout is an annual event sponsored by the American Cancer Society (ACS). It is held on the 3rd Thursday of November. Today, more than 43 million people in the U.S. smoke cigarettes, that is about 1 in 5 adults. Tobacco Free for Healthy NJ is providing resources to help you educate your community as well as direct them cessation services.



The Working Well Tobacco-Free project focuses on Tobacco Prevention and Cessation Services for Young Adults in the Workplace through Wellness Policies. Following best practices, the Working Well Tobacco Free program increases 100% Tobacco Free Worksites and increases the use of effective cessation by young adults 19-29 year olds.

The goal of this project is to enhance statewide efforts to institutionalize comprehensive tobacco free college policies, targeting 18-24 year-old young adults, and create an environment that supports tobacco free living as well as quitting. We provide mini-grants to two and four-year college/universities that do not currently have a 100% tobacco free policy.



TFHNJ works to increase opportunities for Smoke-Free living for all New Jersey residents. We accomplish this by providing assistance to housing authorities, property managers, and landlords who want to implement or improve their Smoke-Free Housing policy, reduce costs attributed to smoking and improve the health of their residents.
